

# Leveraging TAR & Per Document Pricing to Drive 24% Savings

## Matter Summary

A complex, time sensitive litigation matter that required e-discovery and document review resulted in the use of a comprehensive pricing model, and leveraged TAR to complete the request at a significant cost savings for the client.

## Client Challenge

Large financial services firm was facing a large, complex, and time-critical litigation matter with an eDiscovery and document review component with spiraling costs.

## Consilio Response

Consilio applied an integrated pricing model that combined the hosting, project management, review and production work into a single per document reviewed rate that achieved significant costs savings for the Banking Client. To increase review speed, ensure accuracy and allow potentially non-responsive documents to be reviewed at a lower per document rate, Consilio leveraged Technology Assisted Review (TAR) to prioritize the documents and for the purposes of performing quality control checks.

## Results Achieved

Consilio was able to increase the speed and accuracy of the review process using TAR, while helping the client to save cost.

- **TAR and integrated per-document pricing model saves 32.4% (USD172,023) over linear per-hour review and a la carte approach**
- **TAR generated 18.2% review savings even when all documents were reviewed**
- **TAR would have saved 53.8% or USD 186,251 on review costs had documents that were identified as not responsive NOT been reviewed**
- **Integrated per document pricing model saved 50.4% on eDiscovery fees (hosting, professional services & production)**

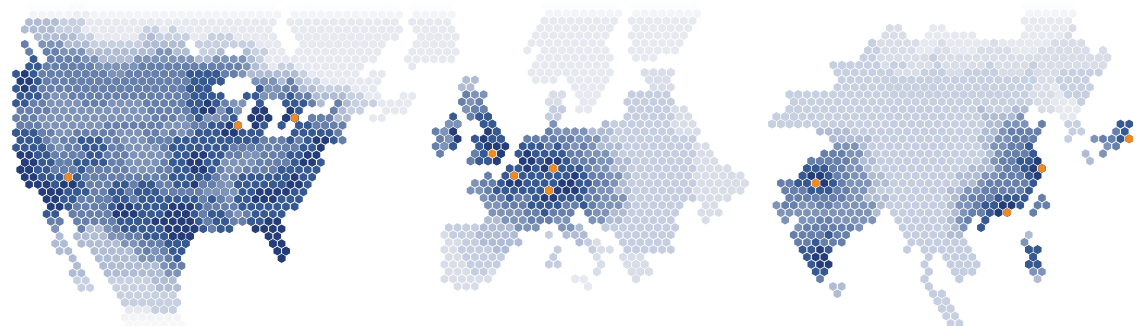
